

# What's behind your lines?




A variety of factors, including platysma muscle contraction, can lead to the appearance of vertical bands connecting the jaw and neck (platysma bands).

## Are there any side effects?

BOTOX<sup>®</sup> Cosmetic may sometimes lead to side effects, which we've reported in our clinical studies. In frown line studies, 3% of patients experienced eyelid drooping. In crow's feet line studies, 1% of patients experienced eyelid swelling. In forehead line studies, 9% of patients experienced headache, 2% of patients experienced eyelid drooping, and 2% of patients experienced brow drooping. There were no additional side effects when treating these 3 areas at the same time.

Other side effects of BOTOX<sup>®</sup> Cosmetic include: dry mouth; discomfort or pain at the injection site; tiredness; headache; neck pain; and eye problems: double vision, blurred vision, decreased eyesight, drooping eyelids and eyebrows, swelling of your eyelids, and dry eyes.
